

7. INTELLECTUAL PROPERTY RIGHTS

7.1 Ownership of all Intellectual Property Rights of one Party (hereinafter referred to as: "Proprietor Party") shall vest in and remain with that Party.
 7.2 Neither Party shall reverse engineer, decompile or disassemble any software comprised in the other Party's Intellectual Property Rights.

8. GOVERNING LAW AND JURISDICTION

By signing this Agreement, the Parties acknowledge that problems and difficulties may arise from time to time. This being the case, the Parties agrees to work together in a spirit of mutual co-operation to resolve and to use all reasonable endeavors to achieve a fair and equitable solution to any such problems and difficulties as may arise.

9. FORCE MAJEURE

Either Party's performance of any part of this Agreement shall be excused to the extent that it is hindered, delayed or otherwise made impractical by the acts or omissions of the other Party for flood, fire, earthquake, strike, stoppage of work due to un-stability or riot or services not under the control of a Party, governmental or military acts or orders or restrictions, terrorist attack; or any other cause (whether similar or dissimilar to those listed) beyond the reasonable control of that Party and not caused by the negligence of the nonperforming Party.

If any Force Majeure condition(s) occur(s), the nonperforming Party shall make reasonable efforts to notify the other Party of the nature of any such condition and the extent of the delay, and shall make reasonable, good faith efforts to resume performance as soon as possible.

10. NOTICES

Any notice or other communication required or permitted to be given under this Agreement shall be given in writing and delivered in person, sent via registered mail, sent via facsimile or electronic mail with machine generated confirmation of transmission or delivered by recognized courier service, without charge to the receiving Party at its address as set out below, and shall be deemed effective upon receipt of such notice.
